## Instructions for deregistering a vehicle

**Deregistration by the owner:** The registered owner must sign the Deregistration Request her/him/themself. If the Request is signed on her/his/them behalf, it must be accompanied by a proxy that has been signed by two witnesses who have reached the age of 18.

**Deregistration without the owner's consent:** The Iceland Transport Authority is authorised to deregister a vehicle without its owner's permission if a competent body has confirmed that the conditions for deregistration are fulfilled (note the reasons for deregistration below). Before the vehicle is deregistered without owner permission, the owner shall be given a month's grace to object to the deregistering.

**Deregistered upon recycling:** If deregistration occurs upon recycling, a <u>certificate of destruction</u> from a recognised collection point must be presented along with the Deregistration Request. It is not possible to register a vehicle again after it has been deregistered as recycled.

**Deposit fee:** The deposit fee is paid only in regard to <u>vehicles</u> that have been <u>deregistered upon recycling</u> (note the conditions above), provided they were registered in Iceland after <u>1 January 1980</u>. The deposit fee amounts to ISK 20,000 and shall be paid only to the registered owner or co-owner; however, public fees accrued on the vehicle will be subtracted from the amount. Upon deregistration, the number of a bank account belonging to the registered owner or co-owner must be stated, whereupon the deposit fee shall be paid directly into that account.

**Export to another country:** It is permissible to deregister vehicles that are being or have been exported out of the country. Proof of export must be presented, either from the export carrier or the Director of Customs. A vehicle will also be deregistered if it has been registered in another country and proof of this, such as the registration certificate, is presented.

Missing vehicle: A vehicle that is missing may be deregistered, given that it has been confirmed by an authorized party.

**Scrap vehicle:** A vehicle that was recorded prior to 1 July 2003 as removed from traffic may be deregistered as scrap, provided the owner declares that it has been disposed of, making it impossible to have a certificate of destruction issued (note the Declaration above).

Vintage vehicle: A vehicle that has reached the age of 25 years (based on the model year or initial registration) may be deregistered, provided the owner declares that the vehicle will be preserved as a collector's item (note the Declaration above).

**Disposal of registration plates:** When a vehicle is deregistered, its registration plates shall be surrendered to the Iceland Transport Authority or an inspection office, unless they have already been recorded as turned in, have been exported with the vehicle or are missing (note the Declaration above). Upon deregistration, the registration plates shall be disposed of.

**Reregistration:** While it is not permissible to reregister a vehicle that was deregistered for recycling or scrapping, reregistration is permissible in other cases.

**Date of deregistration:** The deregistration date shall be considered the day that the Deregistration Request was received by the Iceland Transport Authority or an inspection office, provided that the date of receipt is stated on the Request and was validated by the recipient. However, it is permissible to base the deregistration date on the date of registration overseas (note "Export to another country").

**Insurance, government fees and meter readings:** In regard to insurance premiums, it is the task of the owner to notify the insurance company of a vehicle's deregistration. Government fees are not discontinued upon deregistration, so it may be necessary to have the odometer read when deregistration takes place and then notify the Internal Revenue Directorate of the reading.
